AN ORDINANCE TO AMEND CLARENDON COUNTY ORDINANCE NO. 2015-01, WHICH PREVIOUSLY APPROVED AND ADOPTED THE FISCAL YEAR 2016 BUDGET FOR CLARENDON COUNTY, SOUTH CAROLINA BEGINNING JULY 1, 2015 AND ENDING JUNE 30, 2016.

WHEREAS, Clarendon County finds that it will incur actual expenses within the Fiscal Year 2016 Budget that exceed the amount previously approved in its Fiscal Year 2016 Budget in the amount of \$2,710,000.00;

WHEREAS, Clarendon County finds that these increased expenses are the result of unforeseen circumstances, outside of the control of the County, including, but not limited to catastrophic flooding in October 2015;

WHEREAS, Clarendon County finds that corresponding revenue collections and available fund balance will be in the amount of \$2,710,000.00 which will be equal to the amount of expected expenses of \$2,710,000.00, thus finding the Fiscal Year 2016 Budget of Clarendon County in compliance with the laws of the State of South Carolina; and

NOW THEREFORE, BE IT ORDAINED THAT the County Council of Clarendon County, South Carolina, does hereby approve and authorize the Supplemental Budget Requests as stated below and further amend Clarendon County Ordinance No. 2015-01 to reflect same:




